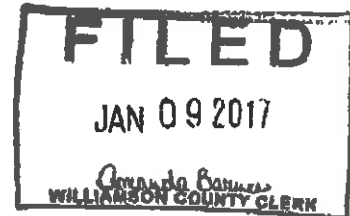

**ORDINANCE NO. 2016-12-02****AN ORDINANCE FOR COIN OPERATED AMUSEMENT AND GAMBLING DEVICES  
VILLAGE OF CRAINVILLE****DEFINITIONS:**

When used in this article, the following words and terms shall have the meanings described to them in this section:

**COIN OPERATED AMUSEMENT DEVICE:** Any machine which, upon the insertion of a coin, slug, token, plate or disk, may be operated by the public generally for use as a game, entertainment, or amusement, whether or not registering a score. The term includes such devices as marble machines, pinball machines, electronic games, skill ball, mechanical grab-em machines and all games, operations or transactions similar thereto under whatever name they may be known.

**GAMBLING DEVICE:** Every clock, tape machine, slot machine or other machine or device for the reception of money or token of value on chance or upon the action of which money or other valuable thing is staked, hazarded, bet, won or lost, or upon the result of the action and operation of which, or a combination of the action of the player and such machine, money or other valuable thing is staked, hazarded, bet, won or lost; or any machine or device which is set into play or operation by the payment of money or other valuable thing to the keeper of such machine or device, or by the insertion into such machine or device of money or other valuable thing, and upon the result of the operation of such machine or the result of the combination of the action of such machine and the action of the person playing the same, prizes or rewards consisting of money, merchandise or other valuable things, are awarded to the person playing such machine, or held out to be awarded to such person, depending upon the result of such operation. The fact that in the operation of any such machine or device, amusement in the form of games or otherwise, shall be afforded to the person playing such machine or device, or that any article or merchandise is vended by such machine or device, shall not take such machine or device out of the class of a "gambling device" if the character and operation of such machine or device otherwise places it within the foregoing definition of "gambling device".

**AMUSEMENT DEVICE LICENSE REQUIREMENTS:**

A. License Required: no person, firm or cooperation shall set up for operation, operate or distribute for the purpose of operation, within the Village of Crainville, or shall keep or maintain, or permit to be kept and maintained, for play or operation, any coin operated amusement device without having a license in full force and effect to do so as provided in this section.

B. Application for License: Any person, firm or cooperation desiring a license to operate, or exhibit for operation for play, a coin operated amusement device within the Village of Crainville shall make application in writing therefore to the village clerk, which applications shall contain

the name or names and address or addresses of the applicant or applicants, the number of the devices and the type or types thereof for which the license is desired. The applicant or applicants shall deposit with the application, in cash, the license fee provided in subsection C of this section.

C. **License Fee:** The annual license fee for said coin operated amusement devices shall be in the amount of \$100.00 for each device.

D. **Issuance or Denial of License:** If the application is in conformity with the provisions of this section, the village president and the village trustee's by simple majority believe the device or devices are used in conformity with the values and standards of the community and if it appears from such application that the device or devices for which said application is made are coin operated amusement devices, as defined herein, the village president shall grant such application, and thereupon, the village president and the village clerk shall issue to such applicant or applicants a license for the public operation of each of such devices, which license shall described the coin operated amusement device for which, if is granted, shall contain the name of the licensee or licensees, and shall specify the expiration date of such license. In the event that no license or licenses are granted by the village president upon such application, the deposit of the license fee accompanying said application shall forthwith be returned to the application or applicants.

E. **Attachment of License to Device:** The license issued for each coin operated amusement device shall be, at all times, affixed to the device for which it was issued in a plainly visible and exposed place thereon, and failure of the licensee or keeper of such device to so affix and keep affixed license, at any time, shall constitute a violation of this.

F. **Expiration of License:** All such licenses shall expire on December 31 next following the date of issuance thereof. No license other than an annual license shall be issued.

G. **Revocation of License:** Any license issued pursuant to this section may be revoked by the village president for good cause.

#### **GAMBLING DEVICES AND GAMBLING PROHIBITED:**

A. **Gambling Devices:** Except for devices licensed by the state in the video gaming act and those used in the administration of the Illinois lottery system, no gambling device shall be kept, maintained or operated within the Village of Crainville.

B. **Gambling:** No keeper or keepers of any coin operated amusement device within the Village of Crainville shall permit or suffer any person or persons to wager, bet or hazard any money or other valuable thing upon the result of the action of such coin operated amusement device or the result of the combination of the action of such device and the player or players.

**INSPECTIONS:**

The police officers of the village are directed to inspect, periodically, each licensed coin operated amusement device for the purpose of determining if said device is operated and used in violation of the provisions of this article.

**GAMBLING AND VIDEO GAMING****GAMBLING ACTS PROHIBITED; EXEMPTIONS:**

A. **Gambling:** No person shall play for money, or other valuable thing or things, at any game with cards, dice, checks, billiards, or any other article, instrument or machine whatsoever, which may be used for the purpose of playing a game of chance, betting or winning or losing money or any other thing or article of value or shall bet on any other game of any type involving gambling unless such gambling is allowed pursuant to the laws or the statute of Illinois and any and all licenses required are obtained for such game of chance.

B. **Possession of Unlawful Gaming Device:** No person shall possess any gambling device or paraphernalia, as defined under and prohibited under the laws or the statute of Illinois, with the intent to use the same for an unlawful purpose, and any such device or paraphernalia kept with such intent may be confiscated by the police department.

C. **Gambling Establishment:** No person shall keep a common gaming house; or in any building, yard, garden or booth, by him or his agent used and occupied, procure or permit any person or persons to frequent to come together to play for money or other valuable thing at any game; or keep or suffer to be kept any tables or other apparatus for the purpose or intent of playing at any game or sport for money or any other valuable thing or knowingly rent any such place for purposes or any such purposes, except those establishments or acts which are authorized as legal under the laws and statutes of Illinois.

D. **Gambling Advertisements:** It is unlawful to advertise any illegal gambling house or illegal gambling resort, as defined under and prohibited under the laws or the statute of Illinois, in any street, alley or public place within the city.

E. **Authorized Gambling:** Nothing in this section shall prohibit authorized, legal wagering, or any acts that are allowed by the laws or the statutes of Illinois.

**LICENSING REGULATIONS:**

A. **General Licensing:** Gambling of any type may be allowed within the village so long as the same is legal within the state of Illinois and if the operator of said gambling or games of chance or any machinery associated therewith has obtained any and all licenses or permits as issued by the state of Illinois.

B. **Video Gaming License:** Each terminal operator as defined by the video gaming act shall obtain a license for each gaming terminal through the Village of Crainville. The licensing

requirements shall be the same as through the state of Illinois video gaming act and approved by the village president and the village trustees by simple majority that the device or devices are used in conformity with the values and standards of the community. The holder of each terminal license shall pay an initial licensing fee of one hundred dollars (\$100.00) per gaming terminal to the Village of Crainville and shall be renewed annually at a fee of one hundred dollars (\$100.00) per terminal to the Village of Crainville. Each such license shall terminate as of January 31, of the next year following its issuance.

C. The village shall limit the number of license holders to two and limit the number of devices permitted within the village to ten.

**PENALTY:**

Any person, firm or corporation violating any provision of this article shall be fined \$250.00 for each offense, and a separate offense shall be deemed committed on each day during or on which a violation occurs or continues.
