Minutes:

Mitchell explained that the line item for engineering is located in the Water Fund. Mitchell will talk to Jilek about moving this line item from the Water Fund into the General Fund.

Sanitary Sewer Update

The contractor is waiting on materials in order to start working on Phase one of the sanitary sewer replacement project.

Municipal Dr. Water Update

Wiggs Exc. told Potts that they are still waiting on pipe to be delivered in order to start the water line extension.

Samuel Road

At the November Board Meeting Rodney Potts told the Board that work has started on Samuel Road. However, there were two spots on the south end of Samuel that after the initial road preparation, water was coming up through the rock. Potts said that in order to get a solid base in which to work on the road they need to remove the initial work and dig deeper to get a solid bottom. Once the solid bottom is located the road preparation will be put back down. The cost to fix these additional spots on Samuel will be \$14,899.05. This brings the total of the road repair on Samuel (includes the change order) to \$161,158.35. Crawford and Associates presented the Board with the Contract Change Order on Samuel Road for \$14,899.05.

Motion 5: Harbin made the motion and Aue seconded the motion to approve Crawford and Associates Change Order on Samuel Road for \$14,899.05. All present voted yea and the President declared the motion carried.

Modglin presented the bill from E.T. Simonds for \$161,158.35 for Samuel Road Repairs. There will be retainage of \$8,057.92. The submitted bill minus the retainage will be \$153,100.43. Potts also presented a bill from B.C. Contracting for \$1,280.00 for doing shoulder work on Samuel Road.

Motion 6: Oetjen made the motion and Rains seconded the motion to pay Estimate #1 to E.T. Simonds Construction \$153,100.43 (bill includes change order #1) for Samuel Road Repairs. All present voted yea and the President declared the motion carried.

Motion 7: Rains made the motion and Aue seconded the motion to pay B.C. Contracting \$1,280.00 for doing shoulder work on Samuel Road. All present voted yea and the President declared the motion carried.
